PROJECT DESCRIPTION

The project proposes to demolish a rear one-story storage shed, and to construct a one-story dwelling unit in the same location. The existing storage shed is at the rear property line with dimensions of 27 feet 6 inches wide, 24 feet 3 inches deep, and 9 feet 2 inches in height. The proposed structure will be at the rear property with dimensions of 27 feet 6 inches wide, 24 feet 3 inches deep, and 10 feet 4 inches in height.

Planning Code Section 134 requires the property to maintain a rear yard that is 45% of the lot depth or average of adjacent neighbors, but in no case less than 25% or 15 feet, whichever is greater. The proposed work falls completely within the required rear yard. Therefore, the project requires a variance.

HEARING INFORMATION

APPEAL INFORMATION

An appeal of the Zoning Administrator's action on a **Variance** may be made to the **Board of Appeals within 10 calendar days** after the Variance Decision Letter is issued by the Zoning Administrator.

An appeal of the approval (or denial) of a **building permit application** by the Planning Commission may be made to the **Board of Appeals within 15 calendar days** after the building permit is issued (or denied) by the Director of the Department of Building Inspection.
