## PROJECT DESCRIPTION

The proposal is to construct 4 dormers at the roof level of the existing structure at the rear of the lot.

**PLANNING CODE SECTION 134** requires the subject property to maintain a rear yard equivalent to 45% of the lot depth or the average of the adjacent buildings. The subject lot contains one building at the front and one at the rear and currently has an existing rear yard equal to 15 feet, located between the two buildings. The proposal is to add dormers to the building located at the rear of the lot, within the required rear yard. Therefore, a variance is required.

### HEARING INFORMATION

Members of the public are not required to provide personal identifying information when they communicate with the Commission or the Department. All written or oral communications, including submitted personal contact information, may be made available to the public for inspection and copying upon request and may appear on the Department's website or in other public documents.

### BUILDING PERMIT APPLICATION INFORMATION

Pursuant to Planning Code Section 311, the Building Permit Application for this proposal may also be subject to notification of property owners and residents within 150-feet of the subject property. The mailing of such notification will be performed separately, if applicable.

### APPEAL INFORMATION

An appeal of the approval (or denial) of a **Variance application** by the Zoning Administrator may be made to the **Board of Appeals within 10 calendar days** after the Variance Decision Letter is issued by the Zoning Administrator.

An appeal of the approval (or denial) of a **building permit application** by the Planning Department or Commission may be made to the **Board of Appeals within 15 calendar days** after the building permit is issued (or denied) by the Director of the Department of Building Inspection.
